Two Oregon Projects Deemed Best of the Year by National

Two Oregon public works projects—the Kronberg Park Multi-Use Walkway, and the Pringle Creek Demolition & Stream Restoration—have been selected by APWA National as 2021 Projects of the Year in their respective categories. APWA officials notified the winning agencies in April, and further recognition will occur at PWX later this summer. Both projects were recognized as Oregon Projects of the Year in 2020.

Each year, APWA presents the Public Works Projects of the Year awards to promote excellence in the management and administration of public works projects, recognizing the alliance between the managing agency, the contractor, the consultant, and their cooperative achievements. Six Oregon projects were submitted for the 2021 National judging in a variety of categories.

"Your selection puts you in a very elite group of winners, and APWA is proud to have those on this project epitomize the public works profession and our association," National APWA Awards and Chapter Relations Associate Rhonda Wilhite said in the notification to the winning projects.



Hugh Kalani

Hugh Kalani, longtime APWA member and former Oregon Chapter president, died April 29. He was 86.

Kalani had a long and distinguished career with Clackamas County, starting as a surveyor and eventually working his way up to road superintendent. He also served on the boards of the Greater Portland Soccer League, the Clackamas River

Water District and Clackamas Credit Union.

At APWA, he was Oregon Chapter president in 1987 and received the Bowes Award in 1993. He was the first person to win the Gizmo.

Kalani is survived by his wife, Ramona, and many children, grandchildren and family. Read Hugh Kalani's obituary.




The attendance for the conference and school rounded out just over 200 attendees for both! We call that a success, but we look forward for in-person events to resume this fall!

Shortage of Surveyors

Surveyors play a crucial role in the design and the construction of projects, gathering information vital to the design for infrastructure projects such as water lines, sewer systems and transportation facilities. Once a design is complete, surveyors take the design and stake it in the field for the contractor to build. That is a very simplified version of the critical role surveyors play, and there is a lot of work behind the scenes related to state law, engineering, and math that a Professional Licensed Surveyor (PLS) performs to make this happen. Without surveyors, design and construction would grind to a halt!

The City of Portland (along with about 45 other public agencies and consultants) is active in the Civil Engineering Cooperative Program (CECOP), which provides sixmonth paid internships to juniors and seniors in Civil Engineering (CE) at Oregon State, Oregon Tech, Portland State, and the University of Portland. In a typical year, about 90 to 100 CE internships are offered. The program also provides internships to students who are interested in surveying. However, CECOP has always struggled to find more than a few students interested in surveying internships to fill the requests from companies. In addition, folks were saying that the availability of surveyors was beginning to impact schedules on some projects.

CECOP reached out to the Oregon State Board of Examiners for Engineering and Licensed Surveyors (OSBEELS) who provided the following information about Professional Licensed Surveyors (PLS) in Oregon:

Year	# of Licensed S	Surveyors (PLS)
2000	2100	
2011	1487	
2014	1022	
2017	963	(711 Oregon residents)
2018	875	(640 Oregon residents)
2020	774	(665 Oregon residents)

The data shows that the number of people with their PLS has declined 63% in the last 20 years!

A surveying task force was formed to look into what could be done to get more students interested in surveying internships. The task force was made up of public agencies (City of Portland and Springfield, ODOT), consultants (David Evans, HHPR, KPFF, and Parametrix), universities (Oregon State and Oregon Tech) and the Professional Land Surveyors of Oregon (PLSO).

Outreach to several universities found that Oregon Tech graduates 5 to 15 students in its geomatics (surveying) program (the school also has a GIS option) per year. OSU has another 5 to 10 CE students on average who sit for the Fundamentals of Land Surveying (FLS) exam. Combined, about 20 students per year from the two schools go on to take the FLS and hopefully their PLS. However, over the last 20 years almost 70 people with their PLS have been retiring every year.

Surveyor Shortage Continues

Task Force Looks at Critical Need

Based upon this information, the surveying task force realized that a multi-pronged approach was needed. The following are some of those recommendations:

- Reach out to middle school and high schools as part of the Science, Technology, Engineering, and Math (STEM) program to get the word out about what surveyors do, and why they are important.
- Restart partnerships between universities, community colleges and PLSO with middle school and high school teachers to train them about surveying and how it could be incorporated into their curriculums as part of their ongoing continuing education requirements.
- Create partnerships between companies and universities to expose high school students to surveying on campus similar what ODOT and Oregon Tech have set up.
- Offer surveying internships to high school and community college students
- Look at options to increase diversity in the profession

The task force had just made these and other recommendations when we received the following demographic information from OSBEELS:

Demographics of Professionally Licensed Surveyors (PLS) in Oregon

Age groups:	Surveyors in age grou
21-30: < 1 %	less than 7
31-40: 10%	77
41-50: 21%	163
51-60: 26%	201
61 and over: 43%	333

We were stunned! 69% of the people with their PLS are older than 50, and 43% are over the age of 60! We realized we have a much bigger and immediate problem that needed to be addressed.

PLSO reached out to the National Society of Professional Surveyors (NSPS) and shared the information. NSPS had heard of similar situations in other states but had never seen actual data. A partnership between PLSO and NSPS is creating a larger task force to come up with additional ideas and partnerships that could be used statewide and potentially nationwide. It includes the following types of organizations:

- Surveying Organizations PLSO, NSPS, Land Surveyors of Washington (LSAW)
- Higher Education OSU, Oregon Tech, PSU, University of Portland, Clark College, Umpqua CC
- State Licensing Board OSBEELS
- Engineering Associations American Council of Engineering (ACEC), APWA, CECOP
- Construction Associations Associated General Contractors (AGC), National Utility Contractors of America (NUCA)

In a future APWA newsletter, we will share the ideas that come from this task force and the next steps that address the shortage of surveyors.

Scholarship Stories

Each year the Oregon APWA Scholastic Foundation awards up to 20 scholarships totaling more than \$30,000. Most of the funding for these scholarships comes from Oregon APWA chapter members. Eligible recipients of the Foundation's scholarship grants are students of Oregon colleges or universities who have achieved junior standing, and whose chosen education field is related to Public Works. Rob Hemphill Portland State University Michael Lindberg Scholarship

Thank you to the APWA for the generous scholarship. At a time of great economic turmoil, the scholarship will make a meaningful impact in my education track.

I am a student at Portland State University's Master of Urban and Regional Planning

program. I also work in the Campus Sustainability Office as a data analyst. As a planner, I am interested in the intersection between land use, transportation, and housing. Public works projects in transportation sit right at the center of those interests. My interest in the field came after completing the Land Use Leadership Fellowship through 1000 Friends of Oregon, examining the Southwest Corridor Light Rail. Following that program, I continued to volunteer, supporting the No More Freeways efforts to seek a restorative justice outcome for the Rose Quarter freeway expansion. I also volunteered with Portland For Everyone as we worked to update city zoning laws to allow for more housing options in residential zones.

As a student, my work in these issues continued. Class projects included partnerships with the Bureau of Planning and Sustainability and Prosper Portland to understand commercial displacement concerns related to the Southwest Corridor Light Rail and a project through the Transportation and Education Resource Center to examine the impact of the built environment on E-scooter parking compliance. The through line in these projects for me is the intersection of our many systems coming together in public spaces and programs; it is imperative that our public infrastructure support the health and well-being of all community members.

Lastly, I am an active user of transportation infrastructure in its many forms. In an average week, I bus, MAX, walk, bike, and rideshare; I also drive occasionally. This broad experience helps me think about mobility in a more expansive way. I experience the difference of commuting by bicycle on a protected bike lane versus a high-stress route. My future planning work will continue to integrate my personal and professional experiences as we build sustainable transportation infrastructure. I thank APWA again for supporting me on this path.


